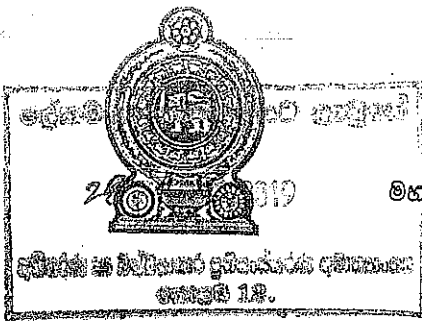

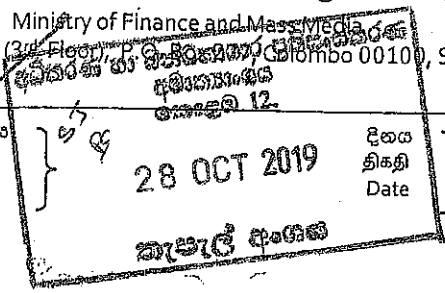



Kindly note that, applicants may select multiple university/s to which he/she wishes to apply from the universities that have concluded an agreement on accepting JICA participants on the condition that the candidate passes the entrance examination of the applying University/s.

- Principally based on the above list of participants, ERD will arrange to submit official nominations to JICA by 18 November 2019 with necessary application documents and endorsements.
- Based on application documents submitted, potential candidates will be requested to attend an interview at JICA Sri Lanka Office on 20 November 2019. Thus, candidates are expected to reserve this date in advance.
