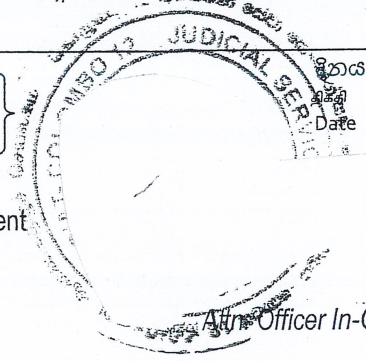

Singapore Cooperation Programme

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries.

To date, over 137,000 officials from more than 180 countries, territories and intergovernmental organisations have participated in our courses and study visits. The SCP is managed by the Technical Cooperation Directorate of the Ministry of Foreign Affairs, Singapore.

Course Objectives

This online course is conducted under the auspices of the SCP Training Award.

This course will introduce the fundamentals of conceptualising and implementing Public-Private Partnership (PPP) projects. It will also share Singapore's experience with PPP projects.

Synopsis

Topics to be covered include:

- PPP Project Development cycle – economic evaluation, costs and benefits; procurement and competitive tender criteria; financing model and risk assessment; and contract management
- Effective regulations and enabling legislation
- Pros and cons of the PPP approach
- Singapore's policies and regulatory frameworks for PPP developments
- PPP Certification Programme Guide

Methodology

This course will be delivered for up to 30 participants through synchronous e-Learning ('live' e-learning sessions), and could include asynchronous e-Learning (self-study e.g. reading materials). There will be Q&A sessions and facilitated group discussions during the 'live' e-learning sessions.

Regulations

Participants are required to comply with the following:

- Strictly observe course schedules and not miss training sessions; and
- Carry out instructions and abide by conditions as may be stipulated by the nominating authority or government and the Government of Singapore and its appointed trainer, with respect to the course.

Duration

The course will be held over five days from 6 to 10 March 2023.

The 'live' e-learning sessions will be tentatively conducted from 1300H to 1800H (Singapore time; UTC/GMT +08:00 hours) daily. More details on the programme schedule will be provided to successful applicants closer to the start of course.

Attendance will be taken for the 'live' e-learning sessions.

Application Information

Applicants should be:

- Mid- to senior-level government officials involved in infrastructure projects planning and management;
- Able to attend all the synchronous e-learning sessions using an internet-enabled device with a functioning webcam, microphone and audio;
- Nominated by their respective governments; and
- Proficient in written and spoken English.

Terms of Award

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award.

Application Procedure

(Closing date for nomination: **13 February 2023**)

The Government of Singapore is pleased to invite the respective National Focal Point for Technical Assistance (NFP) to nominate **one (1)** suitable applicant. Selection of candidates will be based on merit. Should there be more applicants than training places, the Government of Singapore seeks the understanding of the respective NFP in the event that its nominee(s) is not selected.
