This graduate degree program is offered through the Technology Managements, Economics, and Policy Program (TEMEP) at the College of Engineering of Seoul National University. Please be informed that it is entirely the responsibility of the applicant to ensure that all necessary documents are completed and submitted by the specified deadline by email. Therefore, all candidates are strongly encouraged to submit every required document in full and on time.
