We are pleased to inform you that the Japan International Cooperation Agency (JICA) in Sri Lanka has invited nominations for the above training which will be held in Japan from 13th October 2025 to 01st November 2025.

This training program aims to enhance the knowledge of participants on practical methods to implement the UN Convention on the Rights of Persons with Disabilities (UNCRPD) and improve their capacity to contribute to the implementation of the UNCRPD.

Please note that the applicants should be person with disabilities and are middle ranking officers at their organization with a total of 5 – 20 years of experience in the disability field. In addition, they must demonstrate a clear intention to work for their organization upon returning Japan.

The applicants for the program should be nominated in accordance with the General Information (GI) regulations and a copy of the GI booklet is attached for the reference. We seek nominations of candidates who meet the eligibility criteria and each nomination should include the following documents.

1. Nomination letter of the line Ministry
2. For each of the nominee; **two sets** of duly filled Application Form for "JICA Knowledge Co-Creation Programme" – New official Application Form can be downloaded from ERD public website (www.erd.gov.lk). Please note that hand written applications will not be accepted.



Further, please note that only the duly completed applications received by this **office on or before 2.00 P.M. on 23rd July 2025**, with all required documents as stipulated above, will be processed.

In addition, we would like to inform you that the officials already trained under the JICA programme will not be qualified for another JICA training programme within five (5) years of such training.

To ensure the most effective representation of Sri Lanka at this program, we recommend that nominations be made with due consideration to the nominees' subject matter expertise, continuity in the relevant portfolio, and their capacity to contribute substantively to the program agenda. The selected participants are also expected to represent Sri Lanka's national interests in a professional and consistent manner. Therefore, we would highly appreciate your support in identifying the most suitable and deserving candidates for this invaluable opportunity extended by JICA to the Government of Sri Lanka and we look forward to receiving a strong list of nominations.
