

### Justice Data Snapshot: Submission of Justice Snapshot Data

Firstly, I thank and appreciate Mr. Liyanage's valuable participation representing the Secretariat at the Technical Committee meeting on the Justice Data Snapshot, held on **Friday, 25th July 2025** at the Ministry of Justice.

In furtherance of my letter dated 15<sup>th</sup> July 2025 as part of the EU-funded Support to Justice Sector - JURE Project, jointly implemented by UNDP and UNICEF and facilitated by the Ministry of Justice and National Integration.

The Ministry of Justice is in the process of collecting institutional data throughout the Justice sector institutions. The data will gather a statistical account of case data, human resources, material and infrastructure related data.

During the meeting on 25<sup>th</sup> July, UNDP international consultant, Governance Data specialist Ms. Kathryn English, presented the Data Snapshot work that is currently in progress. During the discussion, it was collectively decided by the Technical Committee members, representing all institutions, to support this initiative by submitting the relevant data to the Ministry of Justice.
