We are pleased to inform you that the Government of Japan has invited nominations from eligible government officials in Sri Lanka for the above prestigious long-term Scholarship Programme.

In line with this initiative, the Government of Japan has planned to award 15 scholarships to eligible public sector officials for the Master's Degree Programme for the academic year 2026/ 2027. These scholarships aim to support the professional development of government officials by enabling them to pursue advanced studies at renowned universities in Japan.

The selected fields of study and the corresponding universities for the Master's Degree Programme are outlined in the Annexure I to this letter. These fields have been carefully identified to align with the strategic priorities and developmental goals of our government, ensuring that the beneficiaries contribute effectively to national progress upon completion of their studies.

The qualifications and eligibility requirements for the Master's Degree programme are as follows:

- To be a Citizen of Sri Lanka with the age of 40 or below as of 01<sup>st</sup> April 2026
- To be a Bachelor's Degree holder
- Confirmed officials or completed the probation period and eligible for confirmation.
- Should be "Executive/ Senior Executive", those who are mentioned in the Public Administration Circular No.06/2006, Annexure II, Page 2, IV Senior Level, and Page 5, 3.10 & 3.11
- Officials those who belong to Board of Investment (BOI) can only apply for CP 1-2-3 "Industry Development Policy and Investment Promotion"

6. Officials those who belong to National Building Research Organization (NBRO), Central Environmental Authority (CEA), National Water Supply and Drainage Board (NWSDB), Waste Management Authority (WMA), Urban Development Authority (UDA) can only apply for CP 1-3 "Urban and Regional Development"
7. Should be in good health both mentally and physically
8. English language ability which is sufficient to study at the graduate level
9. Officers fall under any of the following categories are **not eligible** to apply:
  - a. Military personnel registered on the active list or person on alternative military service
  - b. Those who are currently awarded or scheduled to receive another scholarship
  - c. Those who have obtained a master's or higher degree overseas under the support of foreign scholarship

Please note that only duly completed applications for the Master's Degree programme received by the Department of External Resources (ERD) before 2:00 p.m. on 28th October 2025, accompanied by the line ministry covering letter and all other relevant documents as stipulated above, will be processed. Please be advised that the application deadline will be strictly enforced, and any applications received after 2:00 p.m. on 28th October 2025, or without the required documentation, will not be accepted under any circumstances.


